

GENERAL GUIDELINES

WORD COUNT

1500 to 2000 words. Submissions may be excerpted from a longer work but should also function as stand-alone pieces.

DEADLINE

11.59 p.m. Sunday, 3 November 2019, but early submission is appreciated. Late submissions cannot be accepted. Australian Foreign Affairs takes no responsibility for lost or delayed entries.

Submissions will be confirmed by email receipt.

FORMATTING

There are no particular formatting requirements. If in doubt, double-spaced and Times New Roman are safe bets. **Do not include your name on the piece, as entries will be judged blind.**

SUBMISSION

Submissions can only be received electronically. Printed and/or mailed submissions will not be processed. Please submit your piece as a Word document or PDF.

NOTIFICATION

The editors will contact only the authors of the pieces selected for publication. Owing to the number of submissions we receive, editors are unable to comment on individual submissions.

PAYMENT

Upon publication of their work, authors will be paid AU\$100 and will receive a one-year print and digital subscription to Australian Foreign Affairs.

TERMS AND CONDITIONS

The submission must be the author's original work and written in English. Entrants warrant that they are the sole author and copyright owner of the material; that the material has not been licensed for exclusive use in any form in any territory; that the material does not infringe any existing copyright, licence or any other third-party rights; that the material is not in breach of official secrets, confidentiality obligations or any other laws; and that all statements in the material purporting to be factual are true.

Previously published and previously unpublished writers are eligible. Entrants do not have to be Australian citizens or based in Australia. The submission,





however, should fit within the remit of Australian Foreign Affairs, which publishes commentary, analysis and opinion relevant to Australian readers.

Submissions must be previously unpublished. If a submission is accepted for publication elsewhere prior to selection as part of Australian Foreign Affairs' Next Voices series, the author of the work must notify the editors of Australian Foreign Affairs at enquiries@australianforeignaffairs.com, as their entry ceases to be eligible.

Entrants must submit their work using the online submissions form on the Australian Foreign Affairs website. Complete one form per submission. Submissions sent without a completed entry form will not be processed. There is a maximum of three entries per individual.

All submissions will be read blind. The writer's name must not appear anywhere in the document or in the name of the file.

Authors whose work is selected as part of Australian Foreign Affairs' Next Voices series will work with Australian Foreign Affairs editors to edit their submission prior to publication. The editors may suggest alterations to the submission.

Once the author agrees to publish a piece as part of Australian Foreign Affairs' Next Voices series, the author must not offer this piece to any other publications or publish it elsewhere (including on the author's own social media accounts) before it appears on the Australian Foreign Affairs website.

Australian Foreign Affairs will publish the piece within four months of submission. Australian Foreign Affairs has exclusive rights to the piece for twelve months from date of acceptance. During this time, the piece may appear online and/or in print. Should the editors wish to publish the piece in the Australian Foreign Affairs print journal, a separate fee will be negotiated with the author.

The Australian Foreign Affairs editors may decide not to publish any submissions if they do not believe the entries to be of sufficient merit.
